New Zealand Refining Company Scholarship is administered by the Patuharakeke Te Iwi Trust Board.

It provides financial assistance to Students who meet **all** of the following criteria:

The application process requires a written application and may include an interview with representatives of the sponsoring organisation and Patuharakeke Te Iwi Trust Board (Inc).

Details of the interview process will be explained to the applicant when an interview is confirmed.

THE APPLICANT MUST:

- be enrolled in a full time NZQA approved course of study at diploma level or higher at a recognised tertiary educational institute in New Zealand.
- have completed one year or more of successful study in a recognised tertiary educational institute in New Zealand.
- be a direct descendant of the Patuharakeke Hapu
- demonstrate a strong desire to obtain qualification,
- have an interest and involvement in the future wellbeing and welfare of our Hapu.
- send with the application:
 - a verified fees invoice/document with the start date, finish date/duration and tuition fees
- send the fully completed application form in on time – to be received no later than **5pm, Friday 2 of March 2012.**

IMPORTANT INFORMATION:

- The scholarship only helps pay for a small percentage of your tuition fees.
- All applications must be sent to the Patuharakeke Te Iwi Trust Board on or before the closing date. This will be checked by the date stamped by the postal company (Note: Contact your local post shop for the time your mail box is cleared to ensure it will be date stamped for the correct date).
- No missing or corrected information will be accepted after the closing date. The earlier you submit your application the more chance you have of being able to resubmit information if your application is incomplete or ineligible (Note: The Trust cannot guarantee that you will have the chance to resubmit).
- Do not fax or e-mail this application form or any other supporting documentation to the Trust.
- **Successful applicants will be required to report back to the Trust Board and Scholarship Providers at the end of the academic year about their study and results for the year.**

PLEASE PROVIDE:

- A C.V. and cover letter with a current photo
- Name, contact details including residential address (and postal if different)
- Phone numbers (landline and cell) and personal email address for the academic year relevant to the application
- Alternative contact details (as above)
- The name and address of the tertiary institution in which you are enrolled
- Provide a history of academic progress to date and full details of the course to which the scholarship applies
- Communicate a strong desire to obtain qualifications and an awareness of how this qualification will enhance your future.
- Include a statement setting out educational and life aspirations, recent community contributions, including involvement with whanau, hapu and Iwi and your future involvement with community, hapu and Iwi.
